Schoolcraft County emergency manager Chris Peterson gave a presentation about MABS, it is a support system put in place in the event of a major disaster that would allow other fire departments in MI and WI to assist with emergency disasters. This program is free of charge to Doyle and would be paid out by the federal government. Supervisor Hinkson will be setting up a resolution to get this started.
