2. Fire chief Nelson presented the board with a quote from Hunter Garage door for the pole barn
3. Motion made by Clerk Norton to approve the purchasing of new garage door opener and new seals and electric service. Supported by Trustee Huebner. **Motion** carried unanimously.

4. Chief Nelson told of all the new equipment supplied by the Before Our fire hall to yours program. Received thousands of dollars worth of used but good condition equipment including 2 power lift mats that retail at \$40,000, new boots, new air packs, jaws of life, and much more. It was a great success and also helped many volunteer fire departments from all over Michigan.
5. Fire chief Nelson asked the board to purchase battery powered sawzall and a Cut off saw, with some recent acquired donations. Clerk Norton made a motion to buy the two saws, supported by Trustee Huebner, Motion carried.
6. Fire chief Nelson also made some contacts that are willing to come give classes on extracation of victims of a car accident. He will be talking to the chiefs association to see if we can make this happen.
